USA Table Tennis - Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement

- IN CONSIDERATION of being permitted to participate in any way in USA Table Tennis sanctioned events, I and/or my minor child, our personal representatives, assigns, heirs, and next of kin:
- ACKNOWLEDGE, agree, and represent that I and/or my minor understand the nature of Table Tennis Activities and that I and/or my minor child are qualified, in good health, and in proper physical condition to participate in such Activity. I further agree that if at any time I believe conditions or equipment to be unsafe, I and/or my minor child will immediately discontinue further participation in the Activity.
- FULLY UNDERSTAND that (a) TABLE TENNIS ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS AND DEATH ("RISKS"); (b) these Risks and dangers may be caused by me and/or my child's own actions, or inactions, or the actions or inactions of others participating in the Activity, the condition in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I and/or my minor child incur as a result of my participation in the Activity.
- HEREBY ACCEPT AND ASSUME ALL SUCH RISKS, KNOWN AND UNKNOWN, AND ASSUME ALL RESPONSIBILITY FOR THE LOSSES, COSTS, AND/OR DAMAGES FOLLOWING SUCH INJURY, DISABILITY, PARALYSIS, OR DEATH, EVEN IF CAUSED, IN WHOLE OR IN PART, BY THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW;
- HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE USA TABLE TENNIS, their respective administrators, directors, agents, officers, officials, volunteers, and employees, other participants, any sponsors, advertisers, and if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENCE RESCUE OPERATIONS; AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I and/or my minor child, or anyone on my and/or my minor child's behalf, makes a claim against any of the Releasees, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.
- I HAVE READ THIS AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND HAVE SIGNED IT FREELY AND WITHOUT ANY INDUCEMENT OR ASSURANCE OF ANY NATURE AND INTEND IT TO BE A COMPLETE AND UNCONDITIONAL RELEASE OF ALL LIABILITY TO THE GREATEST EXTENT ALLOWED BY LAW AND AGREE THAT IF ANY PORTION OF THIS AGREEMENT IS HELD TO BE INVALID THE BALANCE, NOTWITHSTANDING, SHALL CONTINUE IN FULL FORCE AND EFFECT.

Eligibility:

The 2006 U.S. Open Table Tennis Championships is open to all members of USATT and to members of IITF-affiliated associations.

Rules:

The 2006 U.S. Open Table Tennis Championships will be conducted under the Laws of Table Tennis and the IITF Regulations for International Competitions, except for hard bat events (see below). All decisions made by the Tournament Committee will be final and contestants, upon entering, agree to abide by them.

Venue:

Play will be held mostly on concrete. **Display and/or distribution of any brochures, posters, literature, or written material at the tournament venue is strictly prohibited unless previously approved in writing by USA Table Tennis.**

Equipment:

The official table supplier is Butterfly. White Nittaku three star balls are the Official Approved balls for the 2006 U.S. Open Table Tennis Championships.

Registration:

Players must check-in with the tournament officials at least 30 minutes before their first match and be ready to play each match 10 minutes before the scheduled starting time.

Entries:

Players should have their National Association/Federation approval to enter in the tournament. Players may enter a maximum of eight events, *but may not enter two events starting at the same time.* All matches, both singles and doubles, will be scheduled in advance in each event. Players will receive notification when they register. Each person playing in a doubles event must enter with a partner. USA Table Tennis will NOT be able to arrange for doubles partners. Persons **WILL NOT** be allowed to enter events at the tournament nor will substitution of players be allowed.

Event Scheduling:

Events are not guaranteed to complete on the same day that they begin. NO REFUNDS WILL BE GIVEN FOR EARLY DEPARTURE. Any event may be cancelled and the entry fee for that event refunded if the event contains less than four players, pairs or teams as appropriate. In case of event conflicts, the player is responsible for notifying the Control Desk as soon as possible. In the case of an inadvertent error, liability is limited to the refund of the event fee for the event(s) involved.

Championship Age Events:

+Age events: **9 and Under** - must be born on or after 01/01/1997; **11 and Under** - must be born on or after 01/01/1995; **13 and Under** - must be born on or after 01/01/1993; **Cadet Events** - must be born on or after 01/01/1991; **Junior Events** - must be born on or after 01/01/1988. **Under 21** - must be born on or after 01/01/1985. Players must be at least 30, 40, 50, 60, 65, 70, 75, or 80 as of December 31, 2006 to enter the corresponding events: Over 30, Over 40, Over 50, Over 60, Over 65, Over 70, Over 75, and Over 80 events.

HARD BAT EVENTS

- 1) Hard Bat Rules, as adopted by the USATT Hard Bat Committee, will be used for all hard bat events: a) short pips, no sponge, b) wood bats only, c) any color rubber is acceptable, d) no foot-stomping during service, and e) hats, long pants, long sleeves, etc. are acceptable. See www.hardbat.com for the complete list of official rules.
- 2) As in all events, a question of racket legality is the decision of the Tournament Referee.
- 3) These events do not count for USATT rating points.
- 4) Eligibility for the hard bat rating events will be determined by the player's USATT rating. However, draws for the hardbat events will be conducted on the basis of the ratings maintained by the Hard Bat Committee.
- 5) Players may **NOT** participate in both the U2050 RR and U2000 Hard Bat RR or both the U1450 RR and the U1500 Hard Bat RR. He/She must select which events he/she wishes to play.
- 6) If a participant enters the U2000 Hard Bat RR or U1500 Hard Bat RR and there are insufficient entries, he/she will automatically be moved into the next lowest non-hardbat rating event according to the player's rating.
- 7) All Hard Bat matches will be played to 21 points. All matches will be the best of 3 games, with the exception of the Hard Bat Singles. For the quarterfinals, semifinals, and finals, the Hard Bat singles will be the best of 5 games to 21 points.

Matches:

Men's and Women's singles:

In men's singles top 16 players will be seeded into the main draw of 64 players. In women's singles top 8 players will be seeded into the main draw of 32 players. Depending on the number of entries, all other players will be drawn into qualification RR groups to advance into the main draw. The main draw will be played in a single elimination format. All matches will be played best of 7 games. Semis and Finals will be played at 5 P.M. on Saturday, July 8.

Men's/Women's Doubles:

8 pairs will be seeded into the main draw in these events. The rest of the teams will play qualification matches in a single elimination format. The main draw will consist of 16 doubles pairs and will be played in a single elimination format. Matches in qualification rounds will be played best of 5 games, and in the main draw best of 7 games.

U21 Men's/U21 Women's Singles:

Born on or after January 1, 1985. Top 8 players will be seeded into the main draw in these events. Depending on the number of entries, all other players will be drawn into qualification RR groups to advance into the main draw. The main draw will be played in a single

elimination format. For U21 Men's Singles, the main draw will consist of 32 players, and for U21 Women's Singles, the main draw will consist of 16 players. Matches in qualification rounds will be played best of 5 games, and in the main draw best of 7 games.

Events 07 - 37:

Events 07 - 37 will be best of 5 games to 11 points with the exception of hard bat events(see above)

Doubles Partners:

Players **MUST** enter with a partner in all doubles events. **USA Table Tennis will NOT be able to arrange for doubles partners.**

Age Restrictions:

Players assume the responsibility of entering the appropriate age events. Players who are over/under the age limit of an event will be automatically entered in the correct age event.

Films/Videotapes:

Anyone wishing to make films or videotapes of their own matches or any other matches must receive written permission from USATT, One Olympic Plaza, Colorado Springs, CO 80909.

Likeness Release:

Any image, photographic or otherwise, taken of tournament play or within the official venue is essentially the property of USA Table Tennis regardless of the Approved Camera status of the recording instrument. Entrants agree to allow their voice and likeness in such images to be reproduced in connection with USA Table Tennis by way of any medium.

Deadline:

Entries for the 2006 U.S. Open Table Tennis Championships MUST be received at USATT Headquarters by Monday, June 5, 2006. Entries received after June 5, 2006 WILL NOT BE ACCEPTED.

Withdrawal:

A \$25 processing fee will be charged to any participant who withdraws IN WRITING from the tournament prior to May 25, 2006. **There will be no refunds after this date. There will be no refunds given at the tournament.**

Umpires:

If an umpire is available, a certified umpire will be assigned by the Chief Umpire at the request of any player in a match.

For Your Information:

- 1) No changes in doubles partners, addition or deletion of events, or refunds of event fees will be allowed after the final deadline or at the tournament site.
- 2) USA Table Tennis cannot be responsible for the non-participation of selected doubles partner(s). No refunds will be given for an event if a partner is not available.
- 3) Prize money checks which are not claimed at the tournament site will be mailed to the winner within one month of the conclusion of the tournament.
- 4) Trophies and award certificates not claimed at the tournament site **WILL NOT** be shipped.
- 5) A Social Security Number, or Pertinent Passport Information are required upon receipt of prize money check.
