- **Under 2150** Five players per round robin. Top round robin finisher advances to single elimination. Format: Round robin followed by single elimination. Limit: 15
- **Under 1950** Five players per round robin. Top round robin finisher advances to single elimination. Format: Round robin followed by single elimination. Limit: 15
- **Under 1750** Five players per round robin. Top round robin finisher advances to single elimination. Format: Round robin followed by single elimination. Limit: 15
- **Under 1550** Five players per round robin. Top round robin finisher advances to single elimination. Format: Round robin followed by single elimination. Limit: 15
- **Under 1350** Five players per round robin. Top round robin finisher advances to single elimination. Format: Round robin followed by single elimination. Limit: 15
- **Open Doubles** Format: Round robin followed by single elimination. Limit: 8 teams
- **U-3200 Doubles** Format: Round robin followed by single elimination. Limit: 8 teams

Players may enter 3 (three) events. Ratings gleaned from USATT for seeding; non-rated players seeded by Tournament Director. This is a USATT “1-Star” sanctioned table tennis tournament.

**Other Information:**

Only USATT approved equipment can be used. You must be a USATT member to participate in rated events. You do not have to be a USATT member to participate in any doubles events. All USATT regulations apply; specifically you must not wear a shirt that is predominately ball colored, in this case orange, nor should sleeveless shirts or un-hemmed jean shorts be worn. Insufficient entries may be canceled w/fees refunded. If a rating event is canceled the player will be placed in next higher rated event. Refunds if cancellation is by October 13, telephone entries accepted till October 13. ‘No shows’ money is not refunded.
