Policies: Players may not enter two events with identical start time.
Events with insufficient number of entries can be cancelled
or combined at the discretion of the tournament organizing
committee. No Prizes will be awarded for splits, dumps,
default losses or no-shows. Play will be conducted under
ITTF rules. USATT dress code will be enforced. All referee
decisions are final. ITTF racket testing rule will be enforced.
ITTF OR USATT Approved equipment must be used.

Non Rated (Recreational) Players do not need to have USATT
Membership or USATT rating in Non Rated event.
