Events

- **Jumbo Round Robin:** Format: Twin Round Robins. 5 players per group in 5 groups. Preliminary round robins are played. Preliminary round robin finish determines seeding in the classed round robins: A, B, C, D and E. Completion of classed round robins determines 1st through 5th places. All players play 8 matches. Limit: 25 players
- **Open Singles:** 5 players per Round Robin in 3 groups. Highest player per RR advances to SE. Limit: 15
- **Under 1900:** 5 players per Round Robin in 3 groups. Highest player per RR advances to SE. Limit: 15
- **Under 1600:** 5 players per Round Robin in 3 groups. Highest player per RR advances to SE. Limit: 15
- **Under 1300:** 5 players per Round Robin in 3 groups. Highest player per RR advances to SE. Limit: 15
- **Under 1000:** 5 players per Round Robin in 3 groups. Highest player per RR advances to SE. Limit 15
- **3400 Doubles:** Format: 4 Teams per RR in 2 groups. Highest team per RR advances to SE. Limit 8 Teams
- **Open Doubles:** Format: 4 Teams per RR in 2 groups. Highest team per RR advances to SE. Limit 8 Teams
- **Hardbat Open:** Format: 5 players per RR in 2 groups. Highest player per RR advances to SE. Limit: 10

Players may enter **4 (four) events**. Ratings gleaned from USATT for seeding; non-rated players seeded by the Tournament Director. This is a USATT 1-Star sanctioned table tennis tournament.

Ratings

Player's rating will be based on USATT ratings gleaned from USATT web site 1 week before tournament. Check your rating at www.usatt.org The Tournament Director seeds all non-rated players.

Other Information:

Only USATT approved equipment can be used. You must be a USATT member to participate in rated events. You **do not** have to be a USATT member to participate in Doubles or Hardbat. USATT regulations apply; specifically you must not wear a shirt that is predominately ball colored, in this case orange, nor should sleeveless shirts or un-hemmed jean shorts be worn. Insufficient entries may be cancelled w/fees refunded. If a rating event is cancelled the player will be placed in next higher rated event. Refunds if cancellation is by Dec 1; telephone entries accepted before Dec 1; "no shows" money not refunded. Tournament Director reserves the right to alter formats, times; etc to meet demands of the tourney. Unrated players may advance from their respective round robins.
